#### **Bylaws Committee**

The Bylaws Committee had a meeting scheduled to provide a recommendation to the chapter on the proposed amendments to be voted on at National Assembly. After reviewing proposal #s 23-44, the committee arrived at the following consensus:

- 23. **Support.** No substantive Changes. It was proposed to mirror the established practice.
- 24. **Support**. This proposal is just moving the Bylaws to another section. No substantive changes.
- 25. **Support.** They are just correcting the name of The Links Foundation, Incorporated. No substantive Changes.
- 26. **Support**. This proposal is just providing clarification that the Area Nominating Committee is responsible for nominations for the Area Representatives to The Links Foundation, Incorporated. No substantive changes.
- 27. **Support**. This proposal adds specifications for electing area Foundation reps since the current Bylaws contain no other provisions governing their election.

- 28. **Support**. This proposal simply proposes to remove the word "Secret" as redundant when speaking of voting by ballot. No substantive changes.
- 29. **Support**. This proposal suggests deleting this Bylaw and moving this Bylaw to the procedural manual. No substantive changes since it will be moved and still governing.
- 30. **Support**. This proposal only provides clarification on the Area Election Committee oversight of the election of the Area Representatives to The Links Foundation, Incorporated. No substantive changes.
- 31. **Support**. This proposal brings our current Bylaws in conformity with local D.C. laws, which authorize a non-profit to conduct meetings in a particular manner and codifies the procedure currently used by the Executive Council and Executive Committee. It also allows these two to take action without a meeting by consent as provided by the local D.C. laws. No substantive changes, just codification of current practice.
- 32. **Support**. This proposal suggests a change in wording regarding the chair of the National Nominating Committee, in that she be included in any Bylaw provision relating to the election of National Officers since she is elected in the same manner as the National elected officers. It also suggests striking out some words like "office," since she is not an officer and inserting "position." Finally, it suggests inserting "chair" in lieu of "members" in paragraph F, as the members of the National Nominating Committee include the chairs of the Area Nominating Committees who are elected at their respective Area Conferences. Somewhat substantive, but mainly in line with past practice.
- 33. **Support**. This proposal renumbers the current Bylaws and strikes out the title from "Officers" to "Elected Position," to be in alignment with officers as identified in The Links, Incorporated Constitution. No substantive change to the Bylaw otherwise.
- 34. Support. This provision was suggested to remove the potential penalizing language of the current Bylaw, which appears to prohibit a member of a Chapter in which another member of that Chapter is currently serving as a National Officer from serving as a National officer immediately following the current Chapter member's term. This should be struck out to allow qualified members to serve. This is not a substantive change, it basically clarifies the apparent penalization of "nor serve consecutively" as unnecessary since it is not a conflict of interest nor does it present ethical implications.
- 35. **Support**. This proposal is new and simply identifies practices and responsibilities already in place regarding the National officer who shall be a Parliamentarian. No substantive change.
- 36. **Support**. This proposal is new and simply aligns the requirements already identified in the President's duties. No substantive changes.

- 37. **Support**. This proposal does not change the current wording of this Bylaw, but simply renumbers the sections to be in alignment with officers as identified in The Links, Incorporated Constitution. No substantive changes.
- 38. **Support**. This proposal does not change any substance of the current Bylaw, but simply helps clarify that the National Nominating Committee is an elected position.
- 39. **Support.** This proposal is aligned with the proposal #32, which was supported by National and also our recommendation to support. This proposal does not suggest substantive changes, but recommends matters that are more properly placed in other provisions.
- 40. **Support**. This proposal proposes to delete the "at least 90 days before each National Assembly," language, which refers to the timeframe for the appointment of the National Election Committee. The basis is that this is done much earlier. We support this as the removal of a "restrictive" provision since it is already done much earlier. Substantive change on the time delays within which this should be done. This proposal also recommends the deletion of the requirement that "Members of the Committee shall have attended at least one National Assembly" as attendance does not prepare them for this service. We agree with this proposal as too restrictive without a basis.
- 41. **Support**. This proposal clarifies that the National Assembly elects the "chair of the Nominating Committee." It also clarifies that the chair of the Nominating Committee is elected by ballot and that if there is only one candidate for the position that the candidate may be elected by a method other than ballot.
- 42. **Support.** This proposal suggests amending the current Bylaws to specify the procedure for electing the chair of the National Nominating Committee in the event of a run-off. Not substantive.
- 43. **Support**. This proposal is a change to ensure that members meet all financial obligations due to The Links Organization prior to submission of dues and assessments to National Headquarters. It only adds the word "National" before financial obligations. Not substantive, more clarifying.
- 44. **Support**. This proposal seeks to clarify that the National Election Committee oversees the election of the chair of the National Nominating Committee, not the committee itself, which also includes the chairs of the Area Nominating Committee. Not substantive.
